2017-2018 Financial Agreement

Registration Fee: Annual fee of \$75 per family, due with your application or re-enrollment from. The registration fee is non-refundable and is not deducted from your tuition.

Yearly Tuition: Tuition is based on a ten month school year. If a family qualifies for monthly payments, the total tuition is broken into 10 equal payments.

Materials Fee: The fee for elementary and secondary students is \$200 per child per year. This fee helps defray the cost of educational materials, testing, and supplies. The per student fee is due by June 1 or at the time of registration. It will be pro-rated as a refund only in the event of an early and unavoidable withdrawal prior to the purchase of materials. Certain classes or activities will have additional fees.

Should a check be refused by a bank due to insufficient funds, a fee of \$25 will be assessed to the tuition account. Any grade reports, progress evaluations, or diplomas for students associated with any unpaid tuition will be withheld until all delinquent financial obligations are resolved.

Paying tuition on a monthly basis, rather than in full at the semester's beginning, is a privilege reserved for credit-worthy, conscientious families. COS depends on timely tuition payments to cover the obligations of the school. If you become more than two months delinquent in your account, you may forfeit the privilege of paying monthly.
